RE: MEMORANDUM OF INSTRUCTIONS RE ORPHAN LIST

DATE: May 1, 2023

In our efforts to distribute royalties to Canadian rightsholders, we have compiled a list of what we call “orphans” i.e. titles for which *either* no owner has been identified as being the appropriate claimant for the royalties *or* the claimant has not signed and returned the documentation required by us for royalty distribution. If you have the right to collect the royalties for any titles(s) on the **Orphan List**, we ask that you follow the instructions below.

To make your claim, you will need to print the following documents:

1. **Orphan List**
2. **Program Registration form**
3. **Warranty and Indemnity form**
4. **Authorization Form** (required only if your organization has not yet affiliated with PACC)

In order to claim royalties for any titles from the Orphan List, please complete the following:

1. On the **Orphan List**, clearly mark the title(s) you are claiming with an “X” in the Claim Box;
2. For each title claimed, record the percentage you are entitled to under the column headed “Percent Claimed” (i.e. 100% or a lesser percentage, if applicable);
3. Fully complete the **Program Registration** form for the title(s) you are claiming;
4. Fully complete and sign the **Warranty and Indemnity** form and attach the completed Orphan List and Program Registration(s) to it.
5. If you have not already affiliated with PACC, please complete and sign an **Authorization Form** (Once processed by us, we will countersign and return a copy to you for your files.).
6. Forward these documents to us at the address coordinates below or macura@pacc.ca.

Remember that your entitlement to the royalties arises because:

1. you own the copyright in the program or the right to collect these royalties has been contractually and explicitly assigned to you by the copyright owner; AND
2. your rights apply to the territory and year indicated; AND
3. you have not assigned the right to receive the royalties to a third party e.g. a distributor or agent.

Please note that the ***deadline for our receipt*** of the documentation is ***July 31, 2023***.
