In consideration of the mutual covenants contained herein, the Claimant and PACC agree as follows:

1. The Claimant hereby authorizes PACC on an exclusive basis to act on the Claimant’s behalf to collect, allocate and distribute royalties and other consideration arising from or in connection with private copy levies, exhibition rights in establishments or public places, non-Canadian educational copying and performance, and rental and lending royalties, throughout the world for films and television programs, the rights for which are controlled or administered by the Claimant, and to sublicense such rights to the extent necessary to receive such royalties and consideration on behalf of the Claimant. The Claimant authorizes PACC to communicate with its representatives by email or other electronic means, as required, in matters relating to these activities. This authorization is subject to any limitations of which PACC is notified pursuant to paragraph 3 below.
2. This Authorization shall be effective as from the date hereof (including authorization for PACC to collect royalties and other consideration in respect to prior periods where this is not inconsistent with prior authorizations) and shall continue until December 31 of this year and thereafter shall be automatically continued from year to year for additional consecutive periods of one (1) year, subject to the right of either PACC or the Claimant to terminate this Authorization as at the end of any such one (1) year period by written notice served upon the other not less than four (4) months before the expiry of such period.
3. The Claimant agrees to promptly notify PACC from time to time in the manner prescribed by PACC, of all films and television programs for which the Claimant is the administrator of the above-noted rights, and of any limitations in respect to such rights that may apply in respect to such films or television programs.
4. The Claimant and PACC agree that:
 - (1) PACC’s gross revenue from all sources shall, after deduction of its expenses of and incidental to the collection and distribution of its revenue and the carrying out and administration of its business and operations, be distributed among the Claimant and any other parties who have granted similar authorizations to PACC;
 - (2) distributions shall be made promptly following the calculation of the Claimant’s and such other parties’ shares, it being the intention that insofar as it is possible distributions shall be made annually; and
 - (3) each distribution shall be effected having regard to the total amount of money available in the distribution period, such distribution period to be determined by the board of directors of PACC, and the total number of credits attained by the Claimant and such other parties, such credits to be calculated according to the distribution formula approved by the board of directors of PACC and in effect at the time of such distribution.
